### **LEARNING OBJECTIVES:**

# MUS 327A satisfies the ISU piano proficiency requirement for keyboard majors. Accordingly, after completing MUS 327A, students will be able to:

- Apply practice strategies to sight-read music in various genres (i.e. Classical, vocal and instrumental accompaniments, musical theater, and piano ensembles).
- Transpose: perform (a) excerpts and pieces in a variety of keys, (b) transposing instrumental parts in concert pitch, and (c) movable clefs.
- Harmonize and add various accompaniment patterns to melodies.
- Perform chord progressions using diatonic & secondary dominant chords in all keys.
- Perform 3-4 part open scores from vocal and instrumental literature.
- Create and improvise melodies and accompaniment patterns in a variety of styles

(i.e. Classical, Jazz, 12-bar blues, etc.)

- Read and improvise on lead sheets and figured bass.
- Compose variations on a theme.
- Perform vocal warm-ups.
- Recall information on famous contemporary and historical pianists/organists through a series of historical vignettes presented to the class.

• A minimum grade of a C- (70%) must be earned in order to pass the course.

### **PRACTICE:**

• Daily effective piano practice on the course material is vital in order to be successful in this course. Accordingly, students should practice the course material a minimum of 20-30 minutes, 5-6 days per week.

### **ATTENDANCE:**

- Your attendance is expected at all classes. Written documentation for excused absences (letters of travel from ensemble directors, etc.) must be received no later than two class periods following the absence. No documentation will be accepted once finals have begun. If you do miss for an excused reason, contact your professor within 1 day of your absence for it to be counted as excused.
- Prolonged absences due to illness (more than 2 class periods) will only be excused with documentation from a doctor.
- Exams will not be made up for an unexcused absence.
- One unexcused absence will not affect your final grade. However, each subsequent absence will lower your final grade by one increment (i.e. A- to B+). Six unexcused absences will result in a failing grade. *Two tardies equal one unexcused absence*.
