COURSE SYLLABUS

Course Description

Prerequisite: Consent of instructor

To provide instruction, in a one-on-one setting, that furthers the percussion student in their musical, technical, and professional development. Etudes, exercises, and solo literature appropriate to the area of percussion study will be prepared throughout the semester of study. Progress will be verbally evaluated weekly and recorded in the students' personal files. The student will research all assigned material and provide Performance Notes for all solo works presented during Performance Class, Student Recital, and for jury materials; students should use the format of the Performance Notes described below. Failure to provide this documentation will result in the deduction of one letter grade, per work, from the jury grade. All percussion majors and minors will be required to perform a jury at the end of each semester.

Course Objectives

- 1) Through lesson assignments, private practice, and studio class/jury performance, students will demonstrate the required technical facilities to meet the needs of artistic expression specific to the instruments studied including: orchestral percussion (snare drum, timpani and accessories), keyboards (two and four mallets), and drumset.
- 2) Through textbook, etude and solo study, students will be familiar with a thorough cross-section of pedagogical and solo literature in all areas of percussion.
- 3) Through literature study and performance, students will demonstrate the practical application of theory and aural skills on their performance instrument.
- 4) Through regular solo/ensemble rehearsal and performance, students will demonstrate a working ability to sight-read on all percussion instruments.
- 5) Through studio class, jury, continuation and recital performance, students will demonstrate the physical and mental skills needed to successfully perform in front of an audience.
- 6) Through studio class performance and discussion, students will demonstrate the ability to recognize, evaluate, and correct common percussion performance problems.
- 7) Through studio classes and guest artist visits, students will be aware of new and innovative techniques, literature, the percussion industry, professional artists in the field, and the Percussive Arts Society on a national and worldwide scale.

Course Materials

Students must purchase the literature and equipment recommended by the instructor for use within the semester of private study. Percussion majors are also required to be a current member of the Percussive Arts Society during the semester of private study; membership must be current within two weeks of the beginning of the semester. Students must own original copies of all jury materials. Failure to meet these requirements will result in an Incomplete for the course. Students will also use www.studereo.com to access their weekly lesson assignments, comments, and lesson grades.

- Minimum daily practice time should equal the credit amount of the lesson (i.e. two credit lesson = two hours a day of practice). Daily practice is essential for musical and technical growth and advancement.

Lesson Reflections and Attendance Policy

Each week students are required to submit a brief self-assessment within Canvas the night prior to your lesson. One paragraph (or numbered bullet points) answering the following questions:

- Approximately how much time did you spend practicing this week on materials assigned for lessons?
- Approximately how much time did you spend practicing this week on music other than that assigned for lessons (i.e. ensemble music, hobby practice, wgi/dci, etc...)?
- Approximately how much time did you spend in other activities that enrich your percussion development (i.e. composing, active music listening, etc.)?
- On what assigned material did you primarily work or make the most improvement on this week?
- What are the most notable changes/improvements you made and/or what are any particular issues you are having with you assigned materials this week?

Failure to submit a lesson reflection *prior* to the lesson, results in a lowered grade for that week's lesson by one letter grade.

Make-up lessons will be scheduled when the professor is unable to make the assigned lesson time. Students may reschedule lessons in the event of death in the immediate family, serious illness, or other university approved excuse. Students are also required to attend all on-campus percussion events (degree recitals, concerts, clinics, master classes, etc.). Additionally, students are required to attend and any on-campus event involving a member of the percussion faculty.

General Recitals and Concert Attendance

Students are required to attend 12 concerts or recitals (other than generals) per semester, and should keep a list of events attended with appended programs. Lists of concerts attended will be due at each student's end-of semester applied jury. The policy of the Department also mandates attendance at a Diversity event (which may serve as one of the twelve) each semester: in the case of the Diversity event (only) students are required to turn in a one or two paragraph "review."

It is the responsibility of each student to keep track of the scheduling of the department's General Recitals. These normally fall on Thursdays during the 1:10-2:00 PM time slot, which is a reserved time in all music majors' schedules. Occasionally extra generals are scheduled during Seminar time (1:10-2:00 PM on Tuesdays). Attendance at all Generals Recitals is mandatory.

Performance Notes

Students are required to research and compile performance notes for all pieces presented in performance Class. This work is to be submitted prior to the start of the performance class. However, as it will help to provide valuable information and insight into the preparation of the work, the student is encouraged to begin research when new assignments are received. Each report needs to be at least 1/2 page with 12-point Times font, single-spaced. The information needed for the Performance Notes is as follows:

Juries

BA, BM, BME, and Percussion Minors will take a performance examination at the end of the semester to determine the progress for the semester of study; this is known as a Jury. The performance examination will consist of prepared material (as designated by the instructor), scales*†, and sight-reading on snare drum and two-mallet marimba.

The breakdown for the jury grade will be as follows:

Prepared Materials: 50% Sight-Reading: 25% Scales/Excerpts: 25%

*Scales for the Juries will be studied and prepared as follows:

†Scale format is as follows (Major and all Minor scales):

Sixteenth-note scales (two octaves) followed immediately by triplet arpeggio (two octaves)



Grading Description

The criteria for the final grade will be as follows:

Semester Grade (Attendance, Preparation, Progress, and Performance Class Performances) – 60%

Program notes - 10%

Jury Grade – 30%

118I and 318I (Non-music major applied lessons)

Non-majors will meet for one 30-minute weekly lesson. There is no required concert (or general recital) attendance, and there is no jury requirement. Individuals may be asked to perform during a studio performance class, if schedules allow. The final grade will, then, consist of only the Semester Grade (Attendance, Fulfillment of Requirements, Preparation and Progress), Performance class performances, and program notes.

Senior Recital (Capstone)

1) RECITAL LENGTH

- senior recitals should be 45-60 minutes in length.
- recital length includes time between pieces and equipment moves.

2) SCHEDULING

- It is the responsibility of the student to make sure their major professor is available for the recital date/time before scheduling.

3) RECITAL HEARING

- A hearing must take place a minimum of 2 weeks before the proposed recital date.
- The student will present all of his/her recital repertoire at the hearing. If there are pieces that require additional performers who are not able to attend the hearing, the student must have the pieces cleared by a professor no less than two weeks in advance of the recital. This can be done through video recording or a

rehearsal in which the professor is present.

- Your hearing is a representation of the quality of recital that you are going to play, meaning THE HEARING SHOULD BE AT THE SAME LEVEL AS YOUR RECITAL. If the hearing is NOT passed, the recital must be rescheduled for a later date, or cancelled.
