Welcome you to my voice studio! It is my hope, above all, to cultivate in you a love for all styles of music and performance. To help achieve this, an open mind and communication are paramount to your success. Success, as always, is contingent upon your effort in and out of your private lessons. Each student learns differently, so refrain from comparing yourself to others. The instructor and the student will discover a personalized learning path, as it pertains to the Western Classical Vocal Technique, together. Please, ask questions, think critically about your voice, and enjoy the power of sung word.

### **OUTCOMES**

At the conclusion of each level, students will:

Perform the required repertoire from memory with musical and stylistic accuracy, as well as demonstrate development in vocal technique, pedagogy, breath management, history, and clarity of diction in the assigned languages.

#### **ATTENDANCE**

Attendance is required at all:

1. Lessons/Coachings 2. Seminars 3. Divisionals 4. General Recitals 5. 12 Additional Concerts Attendance is also required at all VOICE Faculty, Guest, and Senior Recitals. Consent for excused absences can only be given only after consultation with the affected student(s) and instructor(s). It is best to send all absence notifications to the instructor via email. If you are sick, or for some other reason, let Professor Sonka know by 10:00am the day of your lesson. All lessons are logged and graded.

The instructor is only required to make-up lessons he has missed. Any lessons missed due to student absences, excused or unexcused, are not guaranteed to be made up and are subject to the instructor's approval.

Any unexcused absences will lower your final grade by one letter (A to A-, A- to B+, etc...)!

#### STUDIO SEMINAR

This is an important part of your vocal development. At weekly seminars (divisional & studio), attention will be devoted to listening, supporting, performance practice, and thinking critically about you and your studio mates' performances.

Each student is required to perform in **at least two** seminars and/or divisionals.

#### REPERTOIRE

Repertoire will be assigned by the instructor. While the student is encouraged to make suggestions, all final decisions regarding repertoire will be made by the instructor. The songs will be selected from the classical and classical musical theatre canon. It is in the student's best interest to keep a running library of the repertoire they have learned, as it will need to be presented at the time of their jury or final.

Non-Majors (118A): Three/Four songs per semester. No fewer than six songs per year with a minimum of two different languages.

<u>First-Year (119A)</u>: Three/Four songs per semester. No fewer than seven songs per year with a minimum of two different languages.

<u>Sophomore (219A)</u>: Four/Five songs per semester. No fewer than nine songs per year with a minimum of three different languages. Continuation Exam.

<u>Junior (319A)</u>: Seven songs per semester (including operatic/oratorio arias). No fewer than fourteen songs/arias per year in at least three different languages. Larger works explored – song cycles/cantatas.

<u>Senior (419A)</u>: Preparation for senior recital. No fewer than fourteen songs/arias per year in at least three different languages. Larger works explored – song cycles/cantatas.

Each student is highly encouraged to record their lessons. No need to purchase an expensive device. More information regarding usage will be given during the first lesson.

#### **ASSIGNMENTS**

In my studio, assignments, while few, are as follows:

*Listening Assignments:* At two points throughout the semester, the student will be expected to complete listening assignments. Assignments will be posted with ample time for completion. On it will be a link to a video/audio clip which the student will listen to and answer the questions that follow on the sheet. These will be discussed in seminar class. Please submit on Canvas by **11:59pm** on the due date listed on the sheet. Those dates are listed below for your reference.

Listening #1: February 19, 2024 Listening #2: April 15, 2024

*Repertoire Assignments:* It is expected that students translate their music and are able to put their songs/arias in historical context **More information regarding format and process will be given during lessons.** 

*Recital Reviews:* Students are required to attend every voice faculty, guest and senior recitals. Students will turn in recital reviews (12) for all required recitals or concerts by the end of each semester – upload these to Canvas. Please include concert title, when & where, and a paragraph description of what you heard. Failure to do so will result in the lowering of your grade. **Those giving recitals this semester are exempt from this assignment.** 

#### **ACCOMPANISTS**

Each student is required to find their own accompanist and compensate them accordingly. Once you've done this, coordinate a lesson time that works best for you, your pianist, and the instructor. Similarly, it is also your responsibility to schedule rehearsal time outside of your regular lesson. PLEASE, out of respect for your pianist, give them copies of your repertoire ASAP. Sight-reading, from both the singer & pianist, will not be tolerated.

### **EXAMINATIONS**

The voice jury (each semester) will be in two parts, performed before the 'jury committee' (voice professors). Part one will be two songs from the repertoire for the semester. The student will choose the first song, and the committee will choose the second. Part two will consist of sight singing and rhythmic examples.

Continuation Exam: In most cases, the second semester of Music 219A culminates with the Continuation Exam. Information and requirements can be obtained through me, Dr. Oakes, your advisor, and https://www.music.iastate.edu/continuation-exam.
